To the Garden Township Board:

On July 11th, 2024 the Planning Commission held a Public Hearing in order review the application from Craig Potvin for a Conditional Use Permit. The minutes for this meeting and Public Hearing are in the records book in the Township Office and are available for review.

At the aforementioned meeting, the Planning Commission had 4 members present and the resulting vote upon the application was a tie vote.

According to the By-Laws of the Planning Commission <u>4.2 Requirements for Action</u> it states that "in the event that the vote results in a tie, then the matter being considered shall be deemed to have been denied".

Section 701-2 of the Garden Township Zoning Ordinance states "The Planning Commission shall recommend to the Township Board approval, approval with conditions, or rejection of the application based upon the materials received and testimony recorded at the Public Hearing".

Therefore, it is the duty of the Planning Commission to formally inform the Garden Township Board that the application by Craig Potvin for a Conditional Use Permit is thus rejected by the Planning Commission.
