Roll Call Vote: Craig – yes, Kathy – yes, Brenda – yes, Sue – yes, and Jenna – yes. Motion carried.

**<u>BITTNER ENGINEERING INVOICE:</u>** Kathy made a motion to pay the bill from Bittner Engineering for \$878.00 regarding repairs to the township hall roof, seconded by Jenna. Roll Call Vote: Sue – no, Craig – yes, Jenna – yes, Brenda – yes, and Kathy – yes. Motion carried. Craig will call Bittner to see if they'll reduce the bill. Brenda will hold the bill until she hears from Craig.
