**911/Fire Signs:** We are looking for volunteers to help with updating addresses and roads for the 911/Fire signs. Steve Lenaker from CUPPAD will instruct our volunteers on what we are asking them to do. These volunteers will be given a grid of an area within the township. This grid will

have the addresses and roads known to CUPPAD. These grids will need to be updated with any new structures or roads. We are recommending teams of two. Once we have updated the grids (small sections of the township area), Steve will go back to CUPPAD and update the entire map of Garden Township with this information. This information will be given to the contractor who will install the signs. Please come to the meeting on **Thursday**, **July 11**, **2019** at 6:30 PM in the Garden Township Hall and bring anyone who you think might be interested in volunteering. We need your support. **Town Hall Septic System and Drain Field**: Ian Nelson, Delta County Health Department, said the septic system and the drain field would have to be replaced. The Village of Garden agreed to let us continue using the existing drain field as long as the Township puts in a three cornered fence that would surround the drain field and the septic tank. The septic system will have to come up today's Health Department Standards. The Township is working with Jacob Allison, Village of Garden President, Ian, and Jason DesJarden of DesJarden Excavating to find out what will need to be done for the septic system and the drain field to come up to Delta County Health Department standards and what it will cost.

**Lighting**: New inside lights installed at the Township Hall. Motion lights (outside) were installed at the Township Hall and at the Fire Department.

**Job Descriptions**: for the Transfer Station and Cemetery/Parks positions were approved.

**Marijuana Ordinance:** The board approved the ordinance to prohibit marijuana establishments within Garden Township.

**Heritage Lease:** Heritage has been requesting and receiving monthly extensions on their lease with the Fire Hall. Their plan is to move out once their new building is completed. They agreed to a 60-day notice to the Township Board and have agreed to convert the furnace back to the way it was before they installed a LP gas tank.

Assessor Contract: for period June 1, 2019 - 31 May 2021 was approved.

**Wind Energy Resolution:** was approved and sent to the Delta County Planning Commission for consideration for inclusion in the updated Delta County Master Plan and Zoning Ordinance.
