CONTRACT between TRI-STAR EMS INC.

AND

BIG BAY De NOC AMBULANCE AUTHORITY

This contract is entered into on ___4 - 25 - 2020____, and is a renewal of the contract between the Big Bay De Noc Ambulance Authority hereinafter "AUTHORITY" and TRI-STAR EMS Inc. hereinafter "AMBULANCE SERVICE" pursuant to Public Act 57 of 1988, as amended, being M.C.L. 124.601 et. Seq. The purpose of this contract is to provide ambulance and emergency care services within the area of the AUTHORITY.

The AUTHORITY and the AMBULANCE SERVICE, in regard to their respective interests hereby agree that:

- AMBULANCE SERVICE shall provide licensed ambulance service within the townships of Nahma, Garden, and Fairbanks. The AMBULANCE SERVICE shall comply with the protocol of the local Medical Control Authority, and the Michigan Public Health Code.
- The AMBULANCE SERVICE shall have control of the ownership and operation of its
 equipment subject to State licensing requirements and the protocol of the local medical
 control authority. The AMBULANCE SERVICE shall have exclusive discretion as to the
 appointment and selection of its officers, staff, equipment, and operation of the
 AMBULANCE SERVICE.
- 3. The AMBULANCE SERVICE shall administer the billing and collection of its fees and costs charged to its patients and their insurers incurred in the operation of the AMBULANCE SERVICE. The AMBULANCE SERVICE shall have the power and authority to maintain accounts, make expenditures, and incur liabilities necessary to transact business as it determines necessary or convenient. The AMBULANCE SERVICE may further purchase, receive, take by grant, bequests, or otherwise deal in and with, real or personal property, as it determines necessary or convenient to carry on its operations.
- 4. The AMBULANCE SERVICE shall provide to the AUTHORITY a list of major expense items and capital costs yearly. The AMBULANCE SERVICE acknowledges that these forms of financial reporting are required to enable the AUTHORITY to establish the funding necessary for the AMBULANCE SERVICE to provide service to the service area.

- 5. In consideration for the service provided by the AMBULANCE SERVICE pursuant to this contract, the AUTHORITY will pay to the AMBULANCE SERVICE a total of \$20,000 annually.
- 6. Prior to March 1st of each year, the AUTHORITY and the AMBULANCE SERVICE may agree to any changes in the amount of funding for the upcoming year. The amount of funding is to be provided to the AMBULANCE SERVICE by the AUTHORITY shall be an appendix to this contract.
- 7. The terms of this contract shall expire on March 31st. 2023. This contract may be terminated by either party with written notice thirty days in advance of the termination, except as provided in section 8.
- 8. In the event that the AMBULANCE SERVICE is no longer licensed under the provisions of the Michigan Public Health Code, this contract shall become immediately null and void.
